

The Kentucky Coal Mining economic impact estimate is a multiregional (2-regions) estimate. The yellow shaded counties form the region of direct employment and production. Additional economic activity will occur outside of the direct employment region providing both indirect and induced effects which emanate from the direct coal employment counties.

Input: 2015

- NAICS: 2121 Coal Mining
- Coal Counties with direct employment = 31 Counties.
- Direct Employment 8,700 (2015 annual);
- Average Annual Base Wage and Salary (without benefits) = \$72,727;
- Average Annual Wage and Salaries (with estimated benefits) = \$87,816; and
- Average Annual Estimated Direct Benefits = 20.8%; and






Eastern Kentucky coal producing counties (2015): Bell, Boyd, Breathitt, Clay, Estill, Floyd, Harlan, Johnson, Knott, Knox, Laurel, Lawrence, Leslie, Letcher, Magoffin, Martin, McCreary, Perry, Pike, Whitley, and Wolfe counties.

West Kentucky coal producing counties (2015): Daviess, Henderson, Hopkins, Livingston, Marshall, McLean, Muhlenberg, Ohio, Union, and Webster Counties.

Note: The list of Kentucky's coal producing counties is based on data provided by the Kentucky Energy and Environment Cabinet, Department for Energy Development and Independence, Division of Carbon

Management and Data Analysis. Only counties with direct employment in the coal mining industry are included based on 4th quarter 2015 employment data.

As indicated by the chart below (Kentucky Coal Mining Jobs) Kentucky had 8,700 coal mining jobs (NAICS 2121) on average during 2015. This economic impact is based on 2015 annual average employment. The coal mining industries employment levels have noticeably decline in a linear trend monthly from the beginning of 2015 to the end of 2015. Therefore, the 2015 economic impact estimate would tend to be front load with more of the annual impact occurring during the early months of 2015 and less occurring during the latter months of 2015. This would indicate that Kentucky's coal mining economic impact at year end (December 2015) is weaker than the 2015 annual average impact estimated in this report.

Social/Economic Cost

This study estimates/reports the positive economic impacts which occur due to employees engaged in coal mining production. This report does not account for the cost incurred by the Commonwealth because of this industry. These costs may include police and fire department services, public education, public infrastructure (roads, bridges, prisons, airports, sewage treatment, water treatment, trash collection, etc.), social services, health services, environmental impacts, and tax incentives/abatements.

Glossary of Economic Impact Terms

Economic impacts are a mathematical method of specifying the economic relationships among all businesses/industries and between businesses/industries and consumers. Input-output (I/O) modeling is the most commonly utilized method to assess the economic outcomes of job creation or reduction. Economic impact modeling captures the direct impact of an employment expenditure (jobs with wages, salaries, and benefits) on the economy. Additionally, the secondary effect (indirect) on the economy is captured and the consumer based (induced) effects are calculated by the model.

Economic impact analysis typically utilizes an economic model input-output (I/O) which traces the flow of goods and services, income, and employment among related sectors of the economy. The I/O model generates a mathematical depiction of the flow of economic activity. *Id Est:*

The Kentucky coal mining industry was the direct producer of 61.4 million tons of coal during 2015 (output). The coal mining industry purchases inputs from other industrial sectors, which in turn purchase inputs from other sectors. Each of these industrial sectors hires employees. Employees of each of these related industries use their wage and salary compensation to purchase goods and services from the economy. Linkages between industries in a region create an economic ripple effect because of changes in demand for products. Strong linkages can lead to a healthier economy, as capital flows through the economy rather than out of it.

Direct Effects: Direct effects are the economic activities occurring during the first round of spending in the 31 coal mining counties (initial employment and wage effect of the coal mining employees). There are 8,700 (2015 annual) direct coal mining jobs in the 31counties.

Indirect Effects: The impact of local industries buying goods and services from other Kentucky industries. The cycle of spending works its way backward through the supply chain until all money leaks from the Kentucky economy, either through imports or by payments to value added. Indirect effects are the changes in sales, income, or employment within the coal mining region. Kentucky's mining industry has backward-linked industries supplying goods and services to the coal mining industry and between each other. These represent the impacts (*e.g.* change in employment) caused by the iteration of industries purchasing from industries. Indirect jobs will be created outside of the coal county region (the primary industry/direct impact industry). The indirect industries supporting the coal mining industry may include maintenance and repair; construction of nonresidential structures; rail transportation; wholesale trade; support activities for oil and gas operations; truck transportation; architectural, engineering, and related services; legal services; accounting, tax preparation, bookkeeping, and payroll services; financial activities; environmental services, *et cetera*.

Induced Effects: The response by an economy to the initial direct and indirect economic activity which occurs through re-spending of income received. This money is recirculated through the household spending patterns causing further local economic activity. New jobs created in the areas of food services, plumbing, medical/dental care, barbershops, clothing sales, police & fire protection, lawn care, legal services, financial services, real estate, merchandize stores, automobile dealers, & service stations, pet grooming, recreational activities, *et cetera*, are due to the direct and indirect effects of the initial direct coal mining industry jobs and the indirect jobs related with coal mining.

Labor Income-Employee Compensation (Includes Benefits): Employee compensation describes the total payroll costs (including benefits). This includes wage and salary payments (by employers) as well as benefits including overtime compensation, health and life insurance, retirement payments, and other non-cash compensation. Significant employment of seasonal and/or part-time workers may lower personal income averages.

Note: Benefits are based on United States Bureau of Economic Analysis Total Compensation for Wages and Salaries paid during 2014 (Compensation of Employees by Industry – Kentucky). This component of personal income benefits is inclusive of <u>employer contributions for employee pension and insurance funds</u> (consists of employer payments to private and government employee retirement plans, private group health and life insurance plans, privately administered workers' compensation plans, and supplemental unemployment benefit plans) and of <u>employer contributions for government social insurance</u>.

Methodology/Sources (partial)

The economic impacts estimates and conclusions resulting from this study have been derived from IMPLAN Group databases. This aggregate database is primarily composed of government data sources including information from
