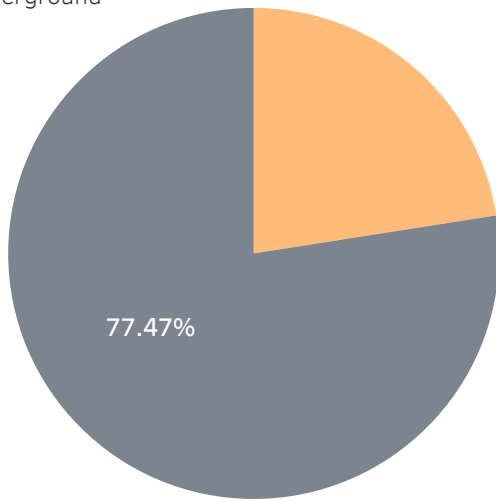


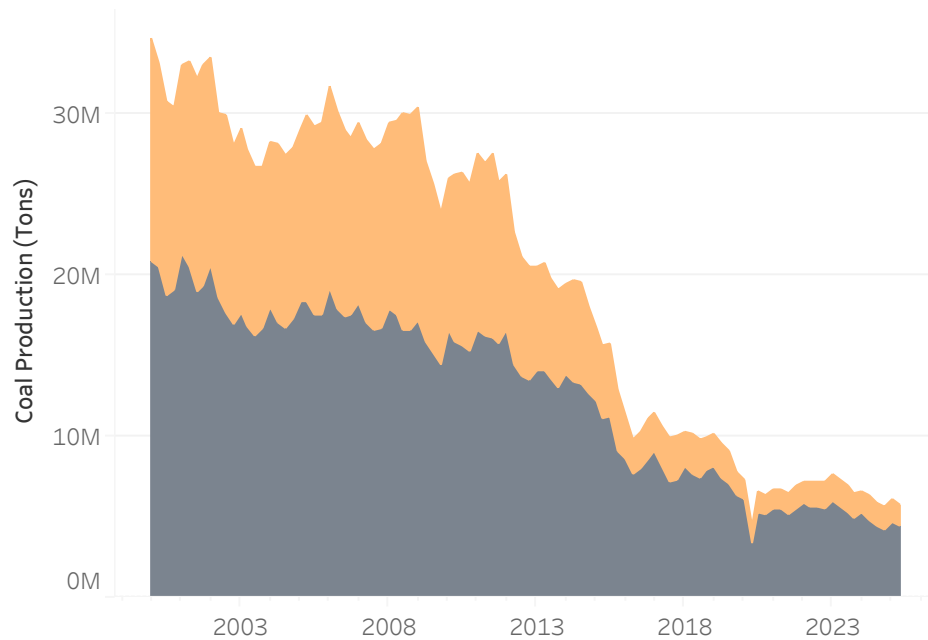

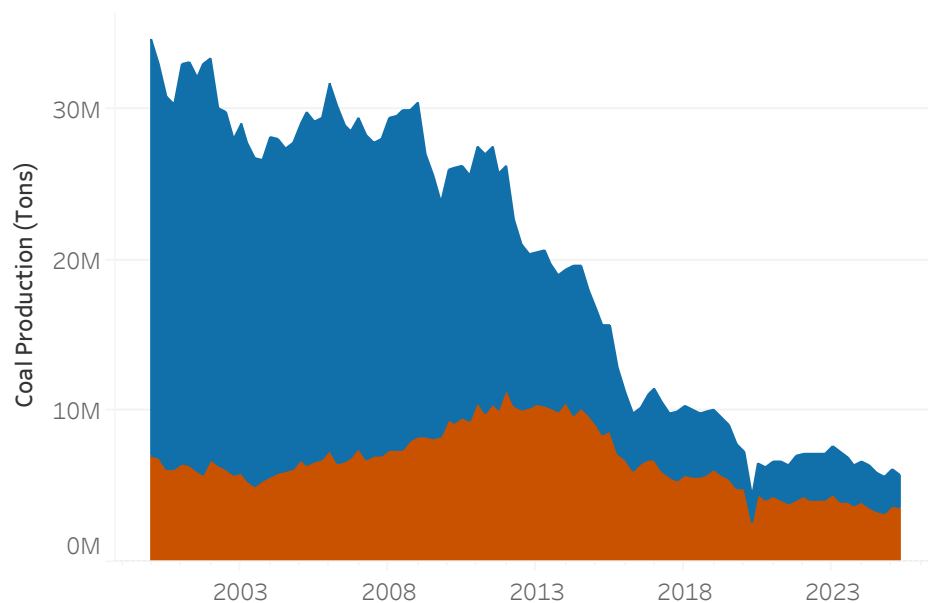


Coal Production by Mine Type (2000 - Q1 to 2025 - Q2)

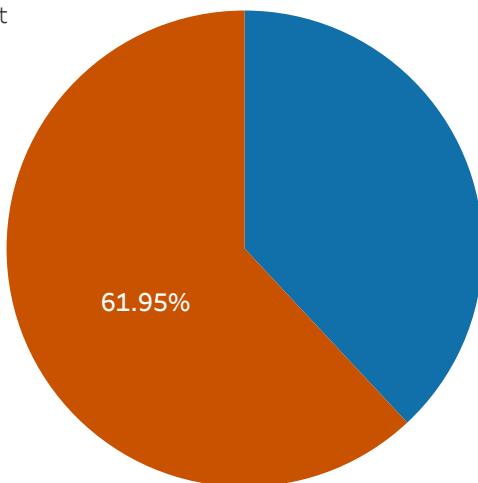

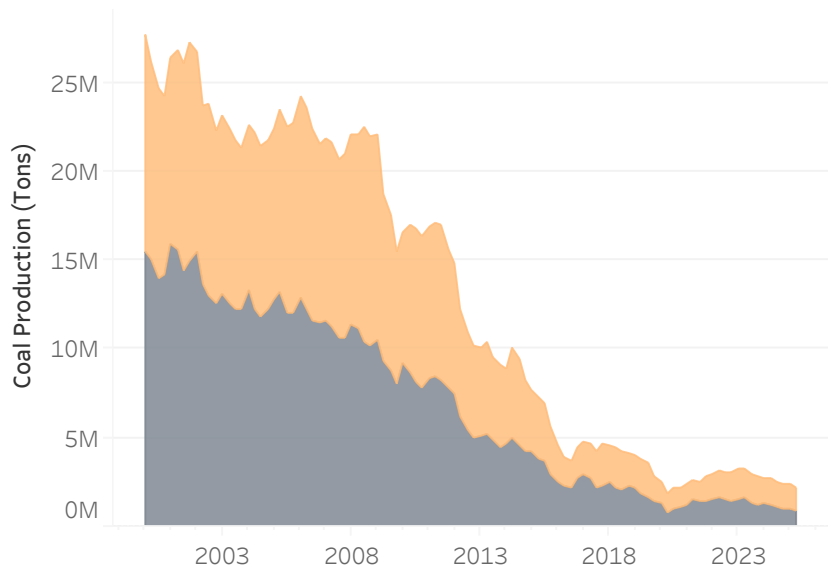

Eastern Kentucky Coal Production (2000 - Q1 to 2025 - Q2)



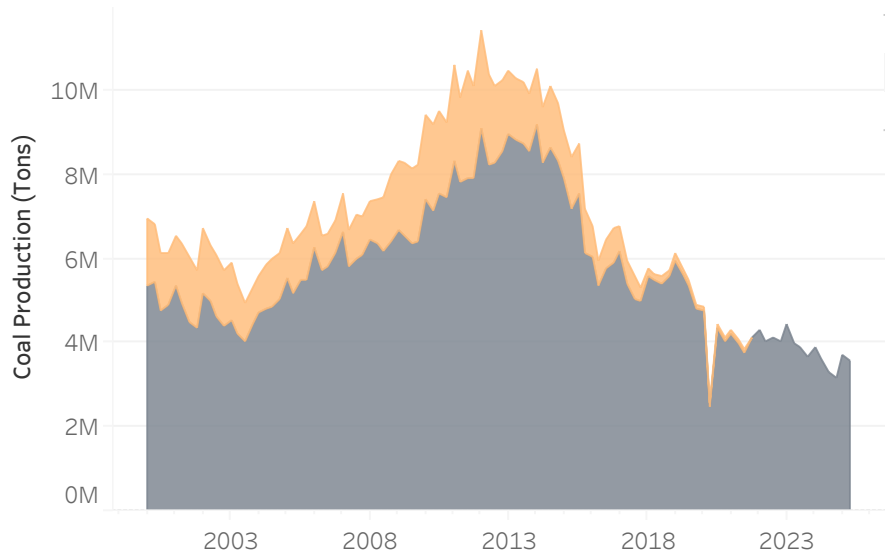

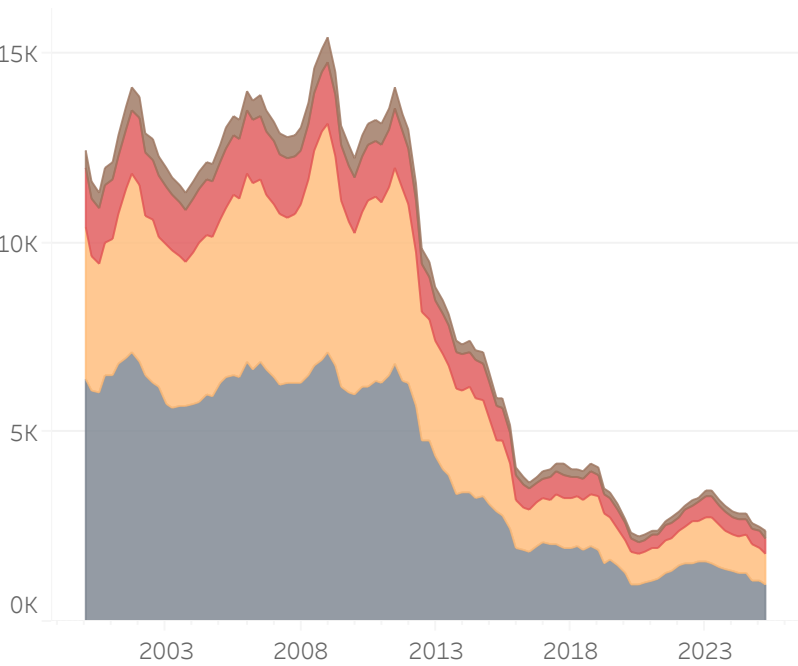
Western Kentucky Coal Production (2000 - Q1 to 2025 - Q2)



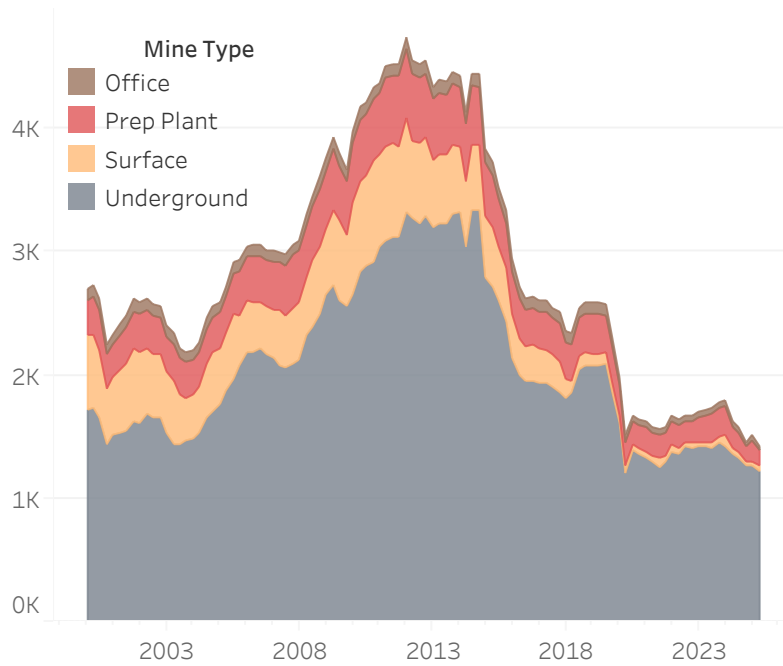
