RE: Submission of Initial Area Designation Recommendations for the 2024 Revised Secondary Annual Sulfur Dioxide National Ambient Air Quality Standard (NAAQS)

Dear Mr. McOmber:

On December 11, 2024, the U.S. Environmental Protection Agency (EPA) promulgated a revision of the existing secondary sulfur dioxide (SO₂) standard of 0.5 parts per million (ppm) as a 3-hour average, not to be exceeded more than once in a year, to an annual standard with a level of 10 parts per billion (ppb), averaged over three consecutive years.¹ This action officially published in the Federal Register on December 27, 2024, and became effective on January 27, 2025. Pursuant to Section 107(d)(1)(A) of the Clean Air Act (CAA), states are required to submit initial area designation recommendations to the EPA no later than one year after promulgation of the new or revised NAAQS; thus, states must submit initial area designation recommendations for the 2024 revised secondary annual SO₂ standard by December 11, 2025.

Using certified air quality data that meets the applicable regulatory requirements, the 2022-2024 design values of all SO₂ monitors in Kentucky are provided in Attachment 1.² This corresponds to the initial area designations memorandum for the secondary annual SO₂ NAAQS issued by EPA that encourages states to submit recommendations based on the three most recent full calendar years of monitoring data (i.e. 2022-2024 monitoring data).³ As demonstrated in Attachment 1, the most current three-year design values at all monitors with certified data are below the secondary SO₂ standard of 10 ppb. Therefore, the Energy and Environment Cabinet (Cabinet) recommends these counties be designated as attainment for the 2024 revised secondary annual SO₂ standard. The Cabinet recommends the remainder of the state be designated as attainment/unclassifiable. The complete list of all counties in the Commonwealth and their



For the secondary SO₂ NAAQS, valid design values must be based on a complete data record from a single, consistent monitoring location, or multiple monitors that have been formally linked due to relocation, over a continuous 3-year period. Data from multiple unlinked monitors, or from periods before and after an unlinked monitor relocation, cannot be combined to calculate a valid design value; the monitors listed in this table that have been relocated were not linked, invalidating their design values.
