Ameresco Benson Valley RNG LLC of 111 Speen Street, Suite 410, Framingham, MA 01701 has applied to the Kentucky Division for Air Quality (Division) for a permit to operate a renewable natural gas facility at 2157 Highway 151, Frankfort, KY 40601. The plant is classified as a Title V major source due to its emissions of non-hazardous regulated air pollutants. This permit contains practically enforceable limitations to restrict this source's potential emissions of VOC to less than PSD major stationary source thresholds.

Any person who requests a public hearing must state the issues to be raised at the hearing. If the Division finds that a hearing will contribute to the decision-making process by clarifying significant issues affecting the draft permit, a hearing will be announced. All relevant comments will be considered in issuing the proposed permit. U.S. EPA has up to 45 days following issuance of the proposed permit to submit comments.
