

AIR QUALITY PERMIT NOTICE

Draft Title V Permit V-18-053 R1

Bituminous Resources, Inc. dba Hopkins County Regional Landfill of 419 Claude Young Road, White Plains, KY 42464 has applied to the Kentucky Division for Air Quality for a significant revision to the permit to construct/operate a second flare at a Solid Waste Landfill facility at 419 Claude Young Road, White Plains, KY 42464. A Title V permit is required for landfills with design capacities greater than or equal to 2.5 million megagrams and 2.5 million cubic meters. Construction authorized by this permit will increase potential emissions of CO by 15.11 tons per year, NO_x by 12.81 tons per year, PM, PM₁₀, and PM_{2.5} by 6.14 tons per year, SO₂ by 123.57 tons per year, VOC by 0.18 tons per year, and total HAPs by 3.75 tons per year.

For a period of 30 days the Division is soliciting comments on the draft permit and affording the opportunity for a public hearing. The first day of the 30 day period is the day this notice is posted on the website above. Comments and/or public hearing requests should be sent to at 300 Sower Boulevard, 2nd Floor, Frankfort, KY 40601 or via email to AIRKentucky@ky.gov. Any person who requests a public hearing must state the issues to be raised at the hearing. If the Division finds that a hearing will contribute to the decision-making process by clarifying significant issues affecting the draft permit, a hearing will be announced. All relevant comments will be considered in issuing the proposed permit. U.S. EPA has up to 45 days following issuance of the proposed permit to submit comments.
