Kentucky Municipal Energy Agency of 1700 Eastpoint Parkway, Suite 220, Louisville, KY 40223 has applied to the Kentucky Division for Air Quality for a permit to construct/operate an electrical power generation facility at 1757 AC Slaton Road, Madisonville, KY 42431. The plant is classified as a Title V major source due to its emissions of non-hazardous regulated air pollutants and hazardous air pollutants. This permit contains practically enforceable limitations to restrict this source's potential emissions of CO,  $NO_x$  and VOC to less than PSD major stationary source thresholds.
