

## AIR QUALITY PERMIT NOTICE

Pratt Paper (KY), LLC / Pratt (Henderson Corrugating), LLC of 6303 Highway 425, Henderson, KY 42420 has applied to the Kentucky Division for Air Quality for a significant revision to the permit to construct/operate a Paperboard Products Manufacturing facility at 6303 Highway 425, Henderson, KY 42420. The plant is classified as a Title V major source due to its emissions of non-hazardous regulated air pollutants. Construction and other changes authorized by this permit will increase potential emissions of Carbon Monoxide (CO) by 2.0 tons per year, Nitrogen Oxides (NO<sub>x</sub>) by 8.9 tons per year and PM<sub>2.5</sub> by 2.6 tons per year.

For a period of 30 days the Division is soliciting comments on the draft permit and affording the opportunity for a public hearing. The first day of the 30 day period is the day this notice is posted on the website above. Any person who requests a public hearing must state the issues to be raised at the hearing. If the Division finds that a hearing will contribute to the decision-making process by clarifying significant issues affecting the draft permit, a hearing will be announced. All relevant comments will be considered in issuing the proposed permit. U.S. EPA has up to 45 days following issuance of the proposed permit to submit comments.
