Tennessee Valley Authority (TVA) of 1101 Market Street, Chattanooga, TN 37402-2801 has applied to the Kentucky Division for Air Quality for a permit to operate a natural gas electric power generation and transmission facility, TVA – Paradise Combined Cycle Plant, at 5562 Rockport Paradise Road, Drakesboro, KY 42337-2345. The plant is classified as a Title V major source due to its emissions of non-hazardous regulated air pollutants.

For a period of 30 days the Division is soliciting comments on the draft permit and affording the opportunity for a public hearing. The first day of the 30-day period is the day this notice is posted on the website above. Comments and/or public hearing requests should be sent to Michelle McCloskey at 300 Sower Boulevard, 2<sup>nd</sup> Floor, Frankfort, KY 40601 or via email to [AIRKentucky@ky.gov](mailto:AIRKentucky@ky.gov). Any person who requests a public hearing must state the issues to be raised at the hearing. If the Division finds that a hearing will contribute to the decision-making process by clarifying significant issues affecting the draft permit, a hearing will be announced. All relevant comments will be considered in issuing the proposed permit. U.S. EPA has up to 45 days following issuance of the proposed permit to submit comments.
