- ² While there is not a permit application fee, annual emission fees may be applicable after the permit is issued. Actual emissions up to 25 tons is a flat fee of \$150. Sources that emit 25 tons or greater receive a fee on a per ton basis.
- ³ Facilities located in nonattainment areas may be subject to additional regulatory requirements which may affect the permit type required. A nonattainment area is a locality where air pollution

"Regulatory Timeframe" indicates the maximum time it should take to receive a final permitting determination from the agency assuming a complete application has been received. Complete permits are often issued before the maximum approval time period is reached..

Hazardous Waste: Generator Registration	ď	\$0 - \$600	No minimum but often reviewed in <30 days	A facility that generates 220 lbs. (100 kg) or more of non-acute or 2.2 lb. (1 kg) of acutely hazardous waste per calendar month must register with the Division of Waste Management. Additional activities that require registration include the recycling and transportation of hazardous waste (excludes on-site transportation) and generation of universal wastes, such as fluorescent lights, pesticides, batteries and thermostats.
Hazardous Waste: Treatment, Storage and Disposal (TSD) Permit ⁶	ď	\$3,700 min.	180 days - 365 days min.	A TSD permit is required prior to the construction or operation of a facility for the treatment, disposal or storage of hazardous waste or storage by a hazardous waste generator for more than 90 days.
Solid Waste: Registered Permit-by -Rule	ď	\$2,500 - \$4,000	Varies: 5-90 days	A registered permit-by-rule is needed for medical and solid waste transfer facilities, composting and land application facilities, one-acre construction demolition debris landfills, and sludge storage and treatment facilities.
