Be it resolved that the Board recommends Mr. Julian and his entire staff, including certified and non-certified staff (operations and maintenance), attend and participate in an ethics and recordkeeping training of two to four hours with Cabinet staff; and

Be it further resolved, the training with the Cabinet staff be scheduled with the Kentucky Operator Certification Program, and if travel is involved, Mr. Julian's utility will be required to reimburse the Cabinet (for related travel expenses of trainers); and

Be it further resolved, any hours obtained do not count towards operator certification education hours for renewals among certified operators; and

Be it further resolved; Mr. Julian provide a corrective action plan to the Kentucky Operator Certification Program by June 30, 2025, to ensure the issue is prevented from happening again.
