The board members concluded their questioning of Mr. Bland around 1:15 p.m.

The board members then began speaking with Mr. John Kessel. The board members asked Mr. Kessel a series of fact-finding questions related to the information provided in his email. In Mr. Kessel's email, he had provided copies of Mr. Redd's applications with discrepancies marked on each one.

The board members concluded their questions of Mr. Kessel around 1:26 p.m.

The board members then began speaking with Mr. Curtis Otto. The board members asked Mr. Otto a series of fact-finding questions related to Mr. Redd's work experience while under his supervision.

The board members concluded their questions of Mr. Otto at roughly 1:39 p.m. EST.

BJ Bland asked Chairman Larry Grubbs if he could follow up with some additional information after a brief discussion with Mr. Redd. Mr. Bland asked Mr. Kessel to clarify what linear assets meant on Mr. Redd's application. After Mr. Kessel's clarification, Mr. Bland explained to the board that linear assets would be considered as operational experience and Mr. Redd would be able to use it as substitutions.

The board is taking no action against Mr. Redd's class II wastewater treatment certification.

The board entered back into executive session for the purpose of reviewing and validating the Wastewater Treatment Exams.
