KNOW ALL PERSONS BY THESE PRESENTS, that the undersigned, _____, as Surety for the Principal, _____, is held and firmly bound unto the Energy and Environment Cabinet in the penal sum of one hundred thousand dollars (\$100,000.00) or two hundred fifty thousand dollars (\$250,000.00), as applicable, by the submission of this surety bond. The penal sum is to assure proper methamphetamine decontamination services of inhabitable properties in accordance with all applicable laws, rules, and regulations.

If the Principal faithfully performs all the requirements of the above designated registration, and complies with all applicable laws, rules, and regulations, and complies with the terms of the attached performance agreement*, then the obligations under this Surety Bond shall be released; otherwise, it is agreed that the undersigned, _____, as Surety, shall pay sum of one hundred thousand dollars (\$100,000.00) or two hundred fifty thousand dollars (\$250,000.00), as applicable, to the Commonwealth of Kentucky, Energy and Environment Cabinet, upon receipt of an Energy and Environment Cabinet Demand Letter.

It is a condition of this Surety Bond that it will be automatically extended for additional periods of up to one (1) year from the then relevant expiry date unless no later than one hundred twenty (120) days prior to that relevant expiry date, the Surety notifies the Registrant and the Energy and Environment Cabinet that the Surety elects not to extend this Surety Bond. For the purposes of this Surety Bond, the Surety's notice not to extend shall mean:

1. That the Surety sends its notification to the Registrant at the above-listed address by registered mail (return receipt requested) and to the Energy and Environment Cabinet, Division of Waste Management ("the Division"), 200 Fair Oaks, 2nd Floor, Frankfort, Kentucky 40601 dated not less than one hundred twenty (120) days prior to expiration; and

2. That, in the event the Surety has failed to notify the Registrant and the Division as described above, this Surety Bond shall be automatically extended for a period of one (1) year: and

3. That, in the event this Surety Bond is not extended, the Surety is not relieved of the obligation for any liability of any violation or omission by the Principal that occurred prior to the relevant expiry date. The Surety is free of any liability to the Energy and Environment Cabinet after the relevant expiry date, providing proper notification of non-renewal was given.

This Surety Bond shall be governed by and interpreted in accordance with the laws of the Commonwealth of Kentucky. Any litigation concerning this Surety Bond shall be taken to the Franklin Circuit Court, Commonwealth of Kentucky.
