The Kentucky Division of Waste Management (Division) has determined that the subject permit action applications are technically complete, and has tentatively decided to issue the permit modifications. Pursuant to 401 KAR 39:060 Section 5, the Division has prepared the draft permit, public notice, and fact sheet. The Division will also schedule a public meeting and public hearing as necessary. The public notice will be published in the Louisville Courier Journal. A short public announcement will also be provided to local radio stations.

Any interested person or party, including the permit owner and operator, has 45 days from the date of the Courier Journal advertisement, February, 28, 2021, to submit comments to the Division. Enclosed are the public notice and the fact sheet that will be sent to persons on the facility mailing list. Also enclosed is a copy of the draft permit. Due to the Covid-19 pandemic, a public meeting will not be held.


