

PUBLIC NOTICE

Pursuant to Application No. APE20180022

The Energy and Environment Cabinet, Division of Waste Management (DWM) received a permit transfer application on September 6 & 7, 2018 proposing to transfer Big Run Landfill to Boyd County Sanitary Landfill, Inc., which is a wholly owned subsidiary of Rumpke of Kentucky, Inc. Further, upon completion of review, the DWM has made a preliminary determination to issue the permit, and has prepared a draft permit.

The permit application is being processed at the Division of Waste Management, Solid Waste Branch, Second Floor, 300 Sower Boulevard, Frankfort, KY 40601.

The application and related information are incorporated into the administrative record and can be reviewed at the Division of Waste Management's Frankfort office between 8:30 AM and 4:00 PM weekdays by appointment only.
