Groundwater Assessment Report for Blue Ridge Landfill Advanced Disposal Services Blue Ridge Landfill, Inc. Agency Interest No. 998 / Application Activity No. AIN20160001

The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch (DWM) proposes to approve a Groundwater Assessment Report for the Blue Ridge Landfill in Estill County and has issued a draft permit.

Advanced Disposal Services Blue Ridge Landfill, Inc. was placed in groundwater contamination assessment pursuant to 401 KAR 48:300 Section 8 for exceedances of chloride and total dissolved solids (TDS) in groundwater monitoring well MW-7. The report demonstrates that the exceedances are most likely a product of natural groundwater conditions (i.e., salt-water impacts) in the New Albany (Chattanooga) Shale. As a consequence, DWM intends to conditionally approve the report and release the Blue Ridge Landfill from groundwater contamination assessment. Additional information may be found in the fact sheet which has been incorporated into the administrative record.

Blue Ridge Landfill is municipal solid waste disposal facility. The name and address of the permit applicant and facility is Advanced Disposal Services Blue Ridge Landfill, Inc., 2700 Winchester Road, Irvine, KY 40336. The contact person is Joe Santangelo at (724) 892-2199. The landfill may be accessed by traveling 3.3 miles on Highway 89 North from Irvine, KY. The permitting action is being processed at the Division of Waste Management, Solid Waste Branch, Second Floor, 300 Sower Blvd., Frankfort, KY 40601.
