Bluegrass Containment LLC Agency Interest No. 3287 / Activity AIN20140002

The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch (DWM) proposes to approve a Groundwater Assessment Report for the Bluegrass Containment LLC Residual Landfill (Permit Number 092-00009) in Ohio County. As originally permitted, the Residual Landfill accepted Coal Combustion Residual (CCR) waste from power plants. In 2002, DWM approved emplacement of Construction and Demolition Debris (CDD) wastes above a constructed liner overlying the coal-combustion wastes to bring the landfill to design grade for final closure.

DWM proposes to approve the Groundwater Assessment Report while requiring continued groundwater monitoring for a modified list of parameters based on waste analysis. After data has been collected from eight sampling events over a period of four years to determine the effectiveness of completed corrective actions, a groundwater assessment report update will be required to be submitted for DWM review. Additional information is available on the fact sheet.

The landfill is permanently closed and is not publicly accessible. The landfill site can be reached by traveling east from Beaver Dam on Highway 62 from its intersection with North Main Street for approximately 4.9 miles. Turn right onto Horton Road and drive south approximately 0.12 miles to the landfill entrance road on the right.
