The Energy and Environment Cabinet, Division of Waste Management, has received a permit renewal application from Bluegrass Containment LLC, for the site located in Ohio County. This facility is closed and is not accepting waste. The applicant proposes to extend the expiration date of Agency Interest No. 45934 (Permit No. 092-00013) to September 20, 2023.

The facility can be accessed by the following directions: At the juncture of U.S. HWY 62 and the Natcher Parkway, head East on HWY 62 toward Daniels Mine Road for approximately 2.5 miles. Turn right onto Horton Rd/Horton-Mt. Pleasant Rd/Mt. Zion Road. After approximately 0.5 miles, turn left to stay on Horton Rd/Horton-Mt. Pleasant Rd/Mt. Zion Rd. Continue to follow Horton-Mt. Pleasant Rd/Mt. Zion Road for approximately 1.2 miles. Destination will be on the left.
