Application for a new Residual Landfill / CC Metals and Alloys LLC
Agency Interest No. 2930 / Application Activity No. APE20180002

The Energy and Environment Cabinet, Division of Waste Management, received an application from CC Metals and Alloys LLC for a proposed landfill located in Marshall County. The administrative portion of the application has been deemed complete. This application, if approved, would allow the construction and operation of a residual landfill.

The proposed landfill location may be accessed by taking S 3rd St and Wayne Sullivan Dr to US-62 E/Clarks River Rd for 3.4 miles. Turn left onto US-60E/US-62E/Clarks River Rd to KY-1523/Industrial Pkwy in Marshall County for 11.0 miles. Turn left onto KY 1523/Industrial Pkwy for 4.4 miles. Turn left onto N Main Street for 0.3 miles. Continue straight for 0.1 mile. Facility will be on the left.

The name and address of both the permit applicant and facility is CC Metals and Alloys LLC, 1542 N. Main Street, Calvert City, KY 42029. The permitting action is being processed at the Division of Waste Management, Solid Waste Branch, 300 Sower Blvd., 2nd Floor, Frankfort, KY 40601.
