

PUBLIC NOTICE

Campbell's Branch Landfill Groundwater Assessment Report

The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch (DWM) proposes to approve a Groundwater Assessment Report for the Campbell's Branch Residual Landfill in Boyd County, and has issued a draft permit.

Campbell's Branch Residual Landfill was placed in groundwater contamination assessment for maximum contaminate level (MCL) and statistical exceedances in well groundwater monitoring wells MW-5A and MW-5B. Subsequent groundwater sampling events showed no MCL exceedances at any of the facility's groundwater monitoring wells as demonstrated in the subject Groundwater Assessment Report. The facility continues to have ongoing groundwater monitoring statistical exceedances and is required to submit a remedial action plan per 401 KAR 48:300 Section 8(9).

The facility can be accessed by traveling from Morehead following signs to get on 1-64 E towards Ashland. Drive for 53 miles then take Exit 191 toward Ashland/Louisa. Turn right onto Country Music Highway and the destination will be on your right.

The Groundwater Assessment Report is being processed at the Division of Waste Management, Solid Waste Branch, 300 Sower Boulevard, Frankfort, KY 40601. The report and related information are incorporated into the administrative record and can be reviewed at the Division of Waste Management's Frankfort office between 8:30 AM and 4:00 PM weekdays by appointment only. To make an appointment or request materials in an alternate format, submit a written request to eec.kora@ky.gov at least 72 hours prior to the desired review date.

Any person who may be aggrieved by the issuance of a permit for this proposed waste site or facility may file with the cabinet a petition which sets forth the grounds of the objection and demands a hearing pursuant to KRS 224.10-420(2).
