

## PUBLIC NOTICE

Pursuant to Agency Interest No. 316 / Application No. APE20200001

The Energy and Environment Cabinet, Division of Waste Management (DWM) received a modification application from Catlettsburg Refining LLC related to their residual landfill in Boyd County. The application proposes to change the design and operations of the landfill.

The name and mailing address of the facility and permit applicant is Catlettsburg Refining LLC, 11631 US 23, PO Box 1492, Catlettsburg, KY 41129. The contact person is Ryan Huddleston, who can be reached by telephone at (606) 921-2423. The facility can be accessed by traveling from I-64, take exit 191 and turn left onto US-23 S. Travel 1.5 miles and turn left onto Campbells Branch. Travel 0.6 miles to site entrance. The facility will be on the right.

The permitting action is being processed at the Division of Waste Management, Solid Waste Branch, 300 Sower Blvd., 2nd Floor, Frankfort, KY 40601. The application and related information are incorporated into the administrative record.
