The application has been determined to be complete and the cabinet has issued a draft permit. This application, if approved, would increase the waste disposal area to 75.56 acres. The current waste disposal area is 32.8 acres for the Contained Landfill and 14 acres for the Construction Demolition Debris (CDD) Landfill; the CDD Landfill area will be converted to a Contained Landfill in its entirety. The permit boundary, which includes borrow areas and facility operations, is proposed to be increased from 102.8 acres to 602.02 acres.

The landfill may be accessed from Georgetown by traveling North on US-25 to Double Culvert Road. Travel right on Double Culvert Road approximately 1.3 miles to the landfill entrance.
