The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch, proposes to approve a Groundwater Assessment Report for the Hancock Creek Special Waste Landfill at the Winchester Headquarters Office in Clark County, Kentucky.

East Kentucky Power Cooperative - Hancock Creek Special Waste Landfill (EKPC Hancock Creek) was put in groundwater contamination assessment for exceedances of boron, calcium, iron, sodium, and sulfate at groundwater monitoring wells MW-2 and MW-3. A risk-based groundwater assessment plan was submitted and approved by the Kentucky Division of Waste Management (DWM). Subsequent groundwater sampling events showed no MCL or alternate MCL exceedances at any of the facility's groundwater monitoring wells. The DWM intends to release EKPC Hancock Creek from groundwater contamination assessment.
