

## PUBLIC NOTICE

Hopkins Co Regional Landfill – Bituminous Resources Inc.

The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch (Branch) received a Notice of Intent (NOI) application from Hopkins Co Regional Landfill to apply for a horizontal expansion (HEX) of the Contained Landfill in Hopkins County. The application proposes to add approximately 31.8 acres of disposal area to the existing operations.

The facility can be accessed by traveling west on US 62, turn left onto N Bob Bruce Dr for 0.6 miles, turn left onto S Church St for 0.2 miles, then turn right, as S Church St becomes KY 913 S / Mt. Carmel Rd for 1.4 miles, then turn right onto Claude Young Rd for 0.9 miles. The facility will be on the right.
