Hopkins County Regional Landfill – Bituminous Resources Inc. Permit Renewal
Application No. APE20240006/Agency Interest No. 38541 / Permit No. 054-00012

The Energy and Environment Cabinet, Division of Waste Management (DWM) received a permit renewal application on January 3, 2025 from Bituminous Resources Inc to renew the solid waste permit for their contained landfill activity. The application proposes to extend the expiration date of Permit No. 054-00012 for the Hopkins County Regional Landfill in Hopkins County to May 26th, 2030.

The name and mailing address of the permit applicant is Bituminous Resources Inc, PO Box 201, White Plains, KY 42464. The facility can be accessed by traveling west on US 62, turn left onto N Bob Bruce Dr for 0.6 miles, turn left onto S Church St for 0.2 miles, then turn right, as S Church St becomes KY 913 S / Mt. Carmel Rd for 1.4 miles, then turn right onto Claude Young Rd for 0.9 miles. The facility will be on the right.

The permit application is being processed at the Division of Waste Management, Solid Waste Branch, 300 Sower Boulevard, Frankfort, KY 40601. The application and related information are incorporated into the administrative record and can be reviewed at the Division of Waste Management's Frankfort office between 8:30 AM and 4:00 PM weekdays by appointment only. To make an appointment or request materials in an alternate format, submit a written request to eec.kora@ky.gov at least 72 hours prior to the desired review date.
