

PUBLIC NOTICE

Pursuant to Application No. APE20200001

The Energy and Environment Cabinet, Division of Waste Management (DWM) received a permit transfer application on January 9, 2020 and additional information on January 16, 2020 proposing to transfer the Kosmos Cement Company permit to Kosmos Cement Company LLC. Further, upon completion of review, the DWM has made a preliminary determination to issue the permit, and has prepared a draft permit.

The facility address is 15301 Dixie Hwy, Louisville, KY 40272. To access the facility traveling west on I-64 take Exit 19A toward KY 841 S/Gene Snyder Freeway/I-265 S. Merge onto I-265 W/KY 841 W/Gene Snyder Freeway/I-265 S for 14.8 miles. Keep left to continue on KY 841 W for 10.4 miles, then take Exit 1 toward US 31W/US 60 toward Fort Knox/Louisville for 0.3 miles. Turn left onto US 31W S/US 60 W (signs for Fort Knox) for 4.5 miles. The facility will be on the left.

The permit application is being processed at the Division of Waste Management, Solid Waste Branch, Second Floor, 300 Sower Boulevard, Frankfort, KY 40601.

The application and related information are incorporated into the administrative record and can be reviewed at the Division of Waste Management's Frankfort office between 8:30 AM and 4:00 PM weekdays by appointment only. To make an appointment or request materials in an alternate format, submit a written request to eec.kora@ky.gov at least 72 hours prior to the desired review date.
