The Energy and Environment Cabinet, Division of Waste Management (DWM) received a permit renewal application on March 17, 2020 from Nelson County Fiscal Court to renew the solid waste permit for the disposal facility. The application proposes to extend the expiration date of Permit No. 090-00001 for Nelson County Solid Waste Disposal Facility in Nelson County to August 6, 2025.

The name and mailing address of the permit applicant is Nelson County Fiscal Court, 113 E Stephen Foster Ave, P O Box 578, Bardstown, KY 40004. The contact person is John C. Greenwell, who can be reached by telephone at (502) 348-1876.

The facility physical address is 1025 Airport Road, Bardstown, KY 40004. The facility can be accessed by traveling on KY 9002 W/Bluegrass Pkwy to US 150 W/Springfield Rd in Bardstown. Take exit 25 toward Bardstown for 0.2 mile. Turn right onto US-150 W/Springfield Rd for 1.4 miles. Continue straight onto E Stephen Foster Ave for 0.8 mile. At the traffic circle, take the 2nd exit onto Court Square and continue onto US 62 W/W Stephen Foster Ave for 3.8 miles. Turn right onto Airport Rd. The facility is in approximately 1.0 mile on the left.

The permit application is being processed at the Division of Waste Management, Solid Waste Branch, Second Floor, 300 Sower Boulevard, Frankfort, KY 40601.

The application and related information are incorporated into the administrative record and can be reviewed at the Division of Waste Management's Frankfort office between 8:30 AM and 4:00 PM weekdays by appointment only.
