The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch (DWM) has reviewed the administrative portion of the application from Nelson County Fiscal Court to expand the landfill at the Nelson County Solid Waste Disposal Facility. This Administrative Application has been deemed complete and has been approved.

The name and address of the permit applicant is Nelson County Fiscal Court, P.O. Box 578, Bardstown, KY 40004. The name and address of the proposed facility is Nelson County Solid Waste Disposal Facility located at 1025 Airport Rd, Bardstown, KY 40004. The contact person is John Greenwell at (502) 348-1876. This facility may be accessed by traveling on KY 9002 W/Bluegrass Pkwy to US 150 W/Springfield Rd in Bardstown. Take exit 25 toward Bardstown for 0.2 mile. Turn right onto US-150 W/Springfield Rd for 1.4 miles. Continue straight onto E Stephen Foster Ave for 0.8 mile. At the traffic circle, take the 2nd exit onto Court Square and continue onto US 62 W/W Stephen Foster Ave for 3.8 miles. Turn right onto Airport Rd. The facility is in approximately 1.0 mile on the left.

The permitting action is being processed at the Division of Waste Management, Solid Waste Branch, 300 Sower Blvd., 2nd Floor, Frankfort, KY 40601. The application and related information are incorporated into the administrative record.
