Application for a Horizontal Expansion to Nelson County Solid Waste Disposal Facility
Agency Interest No. 3267 / Application Activity No. APE20160002

The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch (DWM) received the technical portion of the application from Nelson County Fiscal Court to expand the contained landfill at the Nelson County Solid Waste Disposal Facility. The review has begun on the Technical Application.

The name and address of the permit applicant is Nelson County Fiscal Court, P.O. Box 578, Bardstown, KY 40004. The name and address of the facility is Nelson County Solid Waste Disposal Facility located at 1025 Airport Rd, Bardstown, KY 40004. The contact person is John Greenwell at (502) 348-1876. This facility may be accessed from Bardstown by traveling west on US 62 and turn right onto Airport Rd and arrive at destination.

The permitting action is being processed at the Division of Waste Management, Solid Waste Branch, 300 Sower Blvd., 2nd Floor, Frankfort, KY 40601.
