Pursuant to Application No. APE20200003
Agency Interest No. 2257 / Permit No. 056-00028

The Energy and Environment Cabinet, Division of Waste Management (DWM) received a permit renewal application on March 20, 2020 from Waste Management of Kentucky, LLC to renew the solid waste permit for their disposal facility. The application proposes to extend the expiration date of Permit No. 056-00028 for the Outer Loop Recycling and Disposal Facility in Jefferson County to September 24, 2025.

The name and mailing address of the permit applicant and the physical address of the facility is Waste Management of Kentucky, LLC, Outer Loop Recycling and Disposal Facility, 2673 Outer Loop, Louisville, KY 40219. The contact person is Amy Osborn, who can be reached by telephone at (502) 710-0521. The facility can be accessed by traveling on I 64 W to exit 19A for KY 841 S/Gene Snyder Fwy/I 265 for 0.3 mile. Merge onto I 265 S/KY 841 S/Gene Snyder Fwy for 14.8 miles. Take exit 10A to merge onto I 65 N toward Louisville for 1.4 miles. Take exit 127 for KY 1065 toward Okolona/Fairdale. Turn left onto KY-1065 W/Outer Loop. The facility is in approximately 1.0 mile on the right.

The permit application is being processed at the Division of Waste Management, Solid Waste Branch, Second Floor, 300 Sower Boulevard, Frankfort, KY 40601. The application and related information are incorporated into the administrative record and can be reviewed at the Division of Waste Management's Frankfort office between 8:30 AM and 4:00 PM weekdays by appointment only.
