The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch (DWM) has reviewed the administrative portion of the application from Owl's Head Alloys, Inc.; this Administrative Application has been deemed complete and has been approved. Further, DWM received the technical portion of this application for the new Residual Landfill located in Butler County.

The name and address of the permit applicant is Owl's Head Alloys, Inc., 187 Mitch McConnell Way, Bowling Green, KY 42101. The name and address of the proposed facility is Owl's Head - Butler located on KY 70 in Morgantown, KY 42261. The contact person is Michael Boyle at (270) 842-1300. The proposed facility location may be accessed by taking I-65 exit 91 for US-31W N/KY-61 N toward Paducah/Elizabethtown. Follow signs for Owensboro/Paducah/Western Kentucky Pkwy and merge onto Western Kentucky Pkwy. Take exit 94 for KY-79 toward Caneyville/Morgantown. Turn left onto KY-79 S/Morgantown St to continue on KY 79 S for 16.1 miles. Turn left onto US 231 S for 1.8 miles. Turn right onto Veterans Way for 2.0 miles. The proposed site will be on the right in 0.1 mile.

The permitting action is being processed at the Division of Waste Management, Solid Waste Branch, 300 Sower Blvd., 2nd Floor, Frankfort, KY 40601. The application and related information are incorporated into the administrative record.
