Application for New Residual Landfill

The Energy and Environment Cabinet, Division of Waste Management, Solid Waste Branch (DWM) completed review of the technical portion of the application from Owl's Head Alloys, Inc. for a new residual landfill in Butler County. A draft permit was issued and public hearing was conducted. The name and address of the facility is Owl's Head-Butler located near KY 70 and Gardner Lane Road, Morgantown, KY 42261.

The permitting action is being processed at the Division of Waste Management, Solid Waste Branch. The comment period is being extended from May 12, 2022 to June 12, 2022. Anyone wishing to make comments on the application or draft permit may submit the comment(s) in writing to: Danny Anderson, P.E., Division of Waste Management, Solid Waste Branch, Second Floor, 300 Sower Blvd., Frankfort, KY 40601, no later than June 12, 2022, the end of the comment period. Dear Mr. Anderson:

I'm writing to request a 30-day extension, to June 12, 2022, of the comment period on the technical application and draft permit for a residual landfill in Butler County proposed by Owl's Head Alloys, AI No. 163490, Application No. APE20190001.

The proposed landfill, as you are aware after the public hearing, is a matter of significant local concern in Butler County, and proposes the disposal of waste streams that are of potential public concern due to their characteristics. KRC has committed to assisting local residents in the process of reviewing the proposed landfill both in terms of compliance with applicable siting restrictions and technical compliance with applicable performance and design standards. To that end, KRC is retaining a consultant with experience in landfill design in order to review those issues, and additional time is needed to review the voluminous material associated with the proposed landfill. Additionally, inspection and monitoring-related information associated with another landfill at which the waste streams proposed for disposal at the Owl's Head Alloys landfill are currently being disposed, has been requested from DWM through the ORA but is not yet available for review. The additional time would be of assistance in reviewing that information when it is provided by the Cabinet.

Thank you in advance for your consideration of this request for a thirty-day extension of the public comment period for the proposed Owl's Head Alloys Butler County Residual Landfill Permit No. 016-00024.
