

PUBLIC NOTICE & PUBLIC HEARING

Rumpke of Kentucky Inc - Montgomery Co Landfill
Agency Interest No. 3188 / Application No. APE20250003/ Permit No. 087-00003

The Energy and Environment Cabinet, Division of Waste Management (DWM) received a permit renewal application on October 10, 2025, from Rumpke of Kentucky, Inc. to renew the solid waste permit for their disposal facility, including their contained landfill. The application proposes to extend the expiration date of Permit No. 087-00003 for the Montgomery County Landfill to April 8, 2031.

A public hearing is scheduled for Thursday, February 26, 2026, at the Clay Community Center, 3400 Indian Mound Dr., Mount Sterling, Ky 40343 and scheduled to begin at 5:30 pm eastern. Please note the hearing is not a Question & Answer session. The public hearing is an opportunity for the public to make oral comments for the record on this permitting action, which will be responded to in writing at the same time DWM makes a final determination on the permitting action.

The name and mailing address of the permit applicant is Rumpke of Kentucky Inc., 3990 Generation Dr., Cincinnati, OH 45251. The contact person is William Rumpke who can be reached by telephone at (513) 851-0122. The facility's physical address is, 30 Larison Rd. Jeffersonville, Ky 40337. The facility can be accessed by traveling from Mt. Sterling, KY by heading north on N Bank St toward W. High St. Take KY-11 S/Levee Rd to Larison Rd for 7.7 miles. Turn left onto Larison Rd for 0.7 miles. The facility will be on the left.

The permitting action is being processed at the Division of Waste Management, Solid Waste Branch. Anyone wishing to make comments on the application may attend the public hearing or submit the comment(s) in writing to: Danny Anderson, P.E., Division of Waste Management, Solid Waste Branch, Second Floor, 300 Sower Blvd., Frankfort, KY 40601, no later than February 26, 2026, the end of the extended public comment period.
