

**PUBLIC NOTICE
PUBLIC HEARING**

Pursuant to Application No. APE20160006
Agency Interest No. 33403

The Energy and Environment Cabinet, Division of Waste Management has received a permit renewal application from Waste Services of the Bluegrass, LLC for the Central Kentucky Landfill located in Scott County. The applicant proposes to extend the expiration date of their solid waste landfill permit, #105-00016, to June 30, 2022. A prior public notice was issued on January 19, 2017 pursuant to KRS 224.40-310 (14) for the permit renewal application.

The Energy and Environment Cabinet has scheduled a public hearing to be held on Friday, March 24, 2017 at the Scott County High School, gymnasium, 1080 Cardinal Drive, Georgetown, Kentucky to accept comments on renewal application APE20160006 only. The public hearing, which is an opportunity for the public to make oral comments for the record, will begin at 6:00 P.M. Written comments may also be submitted at the hearing. See solid waste regulation 401 KAR 47:140 Section 10 for public hearings and Section 16 of the same regulation regarding response to comments. Be advised, the comment period for the pending horizontal expansion application (APE20120001) has closed and is not being reopened at this time.

The landfill may be accessed from Georgetown by traveling North on US-25 to KY-620 (Double Culvert Road). Travel right on Double Culvert Road approximately 1.3 miles to the landfill entrance.
