The Energy and Environment Cabinet, Division of Waste Management, has received a permit renewal application from Western Kentucky Regional Services, Inc. to renew the solid waste construction permit for the Western Kentucky Regional Services Landfill in Union County. Construction of the permitted facility has not yet begun. The applicant proposes to extend the expiration date of Permit No. 113-00008 to November 2, 2023.

The location of the proposed facility may be accessed by travelling from Sturgis onto KY 109 to KY-1508, travel approximately 6.7 miles and arrive at destination on left.
