

PUBLIC NOTICE

Williams Landfill / Agency Interest No. 3994 / Application No. APE20260002/ Permit No. 108-00002

The Energy and Environment Cabinet, Division of Waste Management (DWM) received a permit renewal application on July 8, 2026, from Waste Management of Kentucky, LLC to renew the solid waste permit for their facility. The application proposes to extend the expiration date of Permit No. 108-00002 for Williams Landfill in Spencer County to September 9, 2031.

The name and mailing address of the permit applicant is Waste Management of Kentucky LLC, 4636 Adams Center Road, Fort Wayne, IN 46806. The contact person is Christopher Fogt who can be reached by telephone at (260) 409-8245. The facility's physical address is 4876 Kings Church Road, Taylorsville, KY 40071. The facility can be accessed by traveling from Frankfort by merging onto I-64 W for 20.5 miles. Take exit 32 toward Taylorsville then turn left onto KY-55 S/Taylorsville Rd for 8.7 miles. Continue straight onto Elk Creek Rd for 0.1 mile. Turn right onto State Hwy 3192 for 1.9 miles, next turn left onto State Hwy 1319 for 2.8 miles, then turn right to stay on State Hwy 1319. The facility will be on the left.

The permit application is being processed at the Division of Waste Management, Solid Waste Branch, Second Floor, 300 Sower Boulevard, Frankfort, KY 40601. The application and related information are incorporated into the administrative record and can be reviewed at the Division of Waste Management's Frankfort office between 8:30 AM and 4:00 PM weekdays by appointment only. To make an appointment or request materials in an alternate format, submit a written request to eec.kora@ky.gov at least 72 hours prior to the desired review date.
