The Energy and Environment Cabinet, Division of Waste Management, has issued a draft permit

for Louisville Gas & Electric for the Cane Run Station in Jefferson County.

The Division of Waste Management has scheduled a public hearing to be held on Thursday, May

25, 2017 at the Conway Middle School, located at 6300 Terry Road, Louisville KY. The public hearing,

which is an opportunity for the public to make comments for the record, will begin at 6:00 P.M. Written

comments may also be submitted at the hearing. See solid waste regulation 401 KAR 45:050 Section 6

for public hearings and Section 8 of the same regulation regarding response to comments.

The applicant proposes the closure of the former Ash Pond and modification to the approved

closure plan of the existing landfill. Closure caps are proposed to be constructed on the former ash pond

(52 Acres) and the existing special waste landfill designated as Site "A" (110 acres). The former ash

pond and the existing special waste landfill are separate units and shall remain this way after closure.

Portions of the permitted, but unconstructed, special waste landfill (Sites "B" and "C") will not be

developed to the overall permitted capacity. Fifty-five (55) acres of previously permitted landfill acreage

has not been constructed and is proposed to be removed from the permit.

The landfill may be accessed from the intersection of I-264W/US-60 W toward US-31W. Merge

onto Dixie Highway / US-31WS / US-60W. Travel South on Dixie Highway to Rockford Lane. Turn

right on Rockford Lane to Cane Run Road. Turn left on Cane Run Road, Landfill is on the right.
