#### PROPOSED NEW ADMINISTRATIVE REGULATION

The Kentucky Energy and Environment Cabinet filed proposed administrative regulations for 401 KAR Chapter 103, along with materials incorporated by reference. The cabinet will conduct a virtual public hearing on December 21, 2023, at 10:00 a.m. (EST). This hearing will be held to receive comments on the following proposed administrative regulations:

- 401 KAR 103:005 – Definitions related to Merchant Electric Generating Facilities (MEGFs)
- 401 KAR 103:010 – Notification and Transfer Procedures for MEGFs
- 401 KAR 103:020 – Decommissioning Standards for MEGFs
- 401 KAR 103:030 – Financial Requirements for MEGFs

The proposed administrative regulations were necessary to comply with amendments to KRS Chapter 224 and KRS Chapter 278 related to the passage of HB 4 from the 2023 Legislative Session. This regulatory package contains four new administrative regulations and relates to monitoring and enforcement requirements for obligations set forth in KRS Chapter 224 and KRS Chapter 278.

This hearing is open to the public and all interested persons will be given the opportunity to present testimony. The public hearing can be accessed at the following website address:

To assure that all comments are accurately recorded, the cabinet requests that oral comments presented at the hearing are also provided in written form, if possible. It is not necessary that the hearing be held or attended for persons to comment on the proposed administrative regulation. If no request for a public hearing is received by five workdays prior to the hearing, the hearing may be cancelled, and notice of the cancellation will be posted at <https://eec.ky.gov/Environmental-Protection/Waste/Pages/Proposed-DWM-Regulations.aspx>. Written comments should be sent to the contact person and must be received by December 31, 2023, to be considered part of the public record.
