#### Public Hearing Held on Chem Storage Mod and RD&D Permits

The Kentucky Environmental and Public Protection
Cabinet, Division of Waste
Management (DWM) has
tentatively decided to
approve a permit
modification for the Blue
Grass Army Depot (BGAD)
to store hazardous waste,
including chemical
munitions and related
materials (Chemical
Storage), and a Research,
Development and
Demonstration (RD&D)

permit to construct, test, and operate the Blue Grass Chemical Agent-Destruction Pilot Plant (BGCAPP). The BGCAPP is a facility to destroy chemical munitions containing the nerve agent GB. Both of these are Resource Conservation and Recovery Act (RCRA) permits. RCRA is a federal program that is administered by DWM.

After public noticing the Chemical Storage and RD&D permits on Sunday, July 17, comments were accepted for the next 45 days through Wednesday, Aug. 31. A public hearing was held at the Carl D. Perkins Conference Continued on page 5

Destruction Pilot Plant (BGCAPP) was held on Tuesday, Aug. 30, at the Carl D. Perkins Conference Center on the Eastern Kentucky University campus.

The Division for Air Quality (DAQ) was represented by James Morse and Brian Ballard. Morse, the permit support section supervisor, served as the moderator for the portion of the hearing pertaining to the issuance of the draft Clean Air Act, Title V permit for BGCAPP, permit number V-05-034.

The Kentucky Department of **Environmental Protection** (KDEP) had several representatives at the Tier I/ Tier II Meeting held at the Blue Grass Army Depot (BGAD) on Aug. 16-17. Dale Burton, Bill Holskey, Larry Hughes, Eric Ringo, Bill Buchanan, Tim Thomas, Joe Wellner, and Nathan Bentley were present along with various members of the Department of Defense (DOD) and the federal regulatory community.

The agenda for the meeting consisted of updates from

DOD facilities as well as presentations given by KDEP staff and updates on chemical demilitarization. Holskey gave an update on the Naval Ordnance Station in Louisville in which the partnering process was credited for the project's success. Burton informed the team on the status of Kentucky's regulation update. Thomas, principal assistant in the Office of the Secretary, gave a presentation on open burning regulations and the newly-

Center on the Eastern Kentucky University campus on Tuesday, Aug. 30. Beginning at 6 p.m., the Kentucky Environmental and Public Protection Cabinet, Division for Air Quality (DAQ) held a public hearing concerning the Title V air permit for the BGCAPP. The DWM portion of the public hearing followed.

Individuals and groups were afforded the opportunity to comment on the DWM permits. DWM welcomed 42 members of the public and explained the public comment process. A presentation concerning some of the highlights of reviewing the BGAD applications and writing the Chemical Storage and RD&D permits was given. Next, the public was encouraged to make written and/or verbal comments. Written comments were

received from a number of individuals and groups. Craig Williams, representing the Kentucky Chemical Demilitarization Citizens Advisory Board (CDCAB), provided both written and verbal comments.

Currently, the DWM is in the process of reviewing comments and questions received. Responses will be prepared and the permit will be modified if necessary. The DWM will likely issue the Chemical Storage and RD&D permits by Sept. 30. Copies of the final permits and responses to comments will be available to be reviewed at the Richmond and Berea branches of the Madison County Public Library, the Eastern Kentucky University Library, the Blue Grass Chemical Stockpile Outreach Office, and the DWM in Frankfort

items to the locals as a sign of goodwill.

"The kids all want pens, pencils, paper, and, yes, hard candy/cookies," said Barrett in a recent email. "If someone wants to gather up stuff like that and mail it here, we will get it to them."

Some of the items already donated include two garbage bags full of Beanie Babies and stuffed animals; foodstuffs such as beef jerky, candy, and snack crackers; and school supplies such as paper, pencils, and pens.

One of the items persistently requested by the Afghan

children is an American classic--Oreo cookies.

process of designing and constructing the BGCAPP, which will destroy the chemical weapons housed on BGAD. Informational materials such as fact sheets for the recently publicnoticed chemical storage modification and the Research, Development and Demonstration (RD&D) permits, copies of the actual permits, and a display

depicting the process of obtaining a permit were on hand for the public to peruse.

Other participants in the session included BGAD, Blue Grass Chemical Activity (BGCA), Bechtel Parsons Blue Grass (BPBG), Madison County Emergency Management, and Kentucky Division of Emergency Management.

"Children run from wherever to meet our convoys with their thumbs in the air yelling 'Oreo,'" Barrett said.

Some of the items requested for the soldiers' use include inexpensive DVDs, paperback books, snack foods, and toiletries such as razors and mouthwash.

Barrett even made a special request for himself: "If someone wants to support my habit, I chew Copenhagen long cut with the gold lid. There does not seem to be any around here."
