Dear Mayor:

Now is the time to apply for 2027 Litter Abatement Grant funding. The purpose of this letter is to provide you with information about the Litter Abatement Grant program and to provide you with a copy of the grant agreement and related forms. For this grant cycle:

- The signed "City Request and Agreement for Litter Abatement Program Grant Funding," attached, must be received in this office by 4:30 p.m. on November 2, 2026, pursuant to KRS 224.43-505. Litter abatement grant agreements received after that date will not be accepted. Please email documentation to lisa.evans@ky.gov. NOTE: This incorporated form (DEP 7118) is the required form to be used to apply for the 2027 Litter Abatement Grant.
- The amount of grant funding each city is eligible to receive will not be determined until after November 2, 2026. Once all applications are received, the amount of funding available will be calculated in accordance with statutory requirements.
- The litter abatement grant funding is to be used for direct expenses, as defined in 401 KAR 49:080 Section 3, incurred during calendar year 2027, associated with anti-litter control programs; for litter cleanup on public roads as provided in KRS 224.43-505; and to meet the requirements established in KRS 224.43-345.
- By February 1, 2028, the city shall submit to the Kentucky Division of Waste Management a completed "City Litter Abatement Program Annual Report and Certification for Grant Funding" signed by the Mayor. This form should be sent to Lisa Evans at the email address shown in this letter. This form is attached and is also available on our website at <https://eec.ky.gov/rla> and will be sent out to the cities in December through the Kentucky League of Cities. NOTE: This incorporated form (DWM 4900) is the required form to be used to report expenditures for the 2027 Litter Abatement Grant.
- Litter abatement grant funds not spent during calendar year 2027 must be reimbursed to the cabinet by April 15, 2028.
- Per 401 KAR 49:080, Section 6, any city failing to comply with the terms of the litter abatement grant agreement shall be ineligible for litter abatement grant funding for the following year.

- Per 401 KAR 49:080, Section 3(2)(b), “Litter abatement grant program recipients shall keep documentation related to grant activities, including grant expenditure documentation, for at least three (3) years”
- If the city wishes to decline litter abatement grant funding for 2027, please check the box at the bottom of the “City Request and Agreement for Litter Abatement Program Grant Funding” and forward to Lisa Evans
- **Please submit a copy of the city’s solid waste ordinance or solid waste contract to demonstrate compliance with eligibility requirements along with the agreement. Email an electronic copy to Lisa Evans at lisa.evans@ky.gov.**
- There is no match requirement for this grant.
- **Provided with this litter packet is a copy of the guidelines in place by the Division if the city plans to use the Litter Abatement Grant for a “Trash for Cash” program. The guidelines are a part of the litter grant packet, and the city agrees to the guidelines once the city signs the City Request and Agreement for Litter Abatement Program Grant Funding form and submits to the Division.**
- No equipment can be purchased with the grant. No fuel or repairs to equipment is allowed because those expenses are included in the FEMA hourly rate.

If your city is out of compliance with the Department for Local Government or with any of the Division of Waste Management’s grants, you will not be eligible to receive a grant for 2027.

The disbursement of the litter abatement grant funding will be prior to January 1, 2027. Please provide the city’s address as registered with the Kentucky Finance Cabinet and the city’s Federal ID information on the Litter Abatement Grant Funding agreement. **Submit the signed form and a copy of your ordinance or contract by 4:30 p.m., on November 2, 2026, via email to lisa.evans@ky.gov.**
