Reporting Solid Waste Management Programs

Each Solid Waste Management Area Governing Body (fiscal court, 109 Board or city) is statutorily required to submit various reports to the state for review and approval. Kentucky's solid waste planning laws, found in KRS 224.43-310 through KRS 224.43-380, outlines the specific reporting requirements for the following: comprehensive planning, jurisdictional authority, solid waste collection, solid waste disposal facilities, facility siting, authoring capacity for landfills, waste reduction, waste diversion, litter abatement, dump cleanups, enforcement procedures and public outreach. To that effect, the Kentucky Division of Waste Management's Local Planning and Assistance Section assists local government with instructions and guidance for completing these reports. Upon submittal, these reports are reviewed for accuracy and compliance. The reporting requirements are summarized below:

1) Form – DEP 6062 Solid Waste Management Plan Update

Purpose: Create a framework for providing and implementing local solid waste programs.

Responsible Entity: Governing Body of Solid Waste Management Area (fiscal court or 109 Board).

2) Form – DEP 6062 Solid Waste Management Plan Amendment

Purpose: Amend Solid Waste Management Plan during the 5-year planning cycle as needed.

3) Form – DEP 6061 Solid Waste Management Annual Report

Purpose: Provide quantitative data on the status of solid waste programs on an annual basis.

4) Form – DEP 5033 Municipal Solid Waste Collector and Recycler Registration and Report

Purpose: Provide information for municipal solid waste collector and recycler activities.

Responsible Entity: All Municipal Solid Waste Collectors and Recyclers [report to county].

5) Form – Annual Authorized Capacity Report

Purpose: Provide permitted and authorized capacity for landfills on an annual basis.

6) Form – Certification for Local Determination
