

Notice of Intent (NOI) for Storm Water Discharges from Small Municipal Separate Storm Sewer Systems(SMS4) KPDES General Permit

Submission of this Notice of Intent constitutes notice that the party identified in Section I of this form intends to be authorized by a KPDES permit issued for storm water discharges from a small municipal separate storm sewer system (SMS4). Becoming a permittee obligates such discharger to comply with the terms and conditions of the permit.

Notice of Intent (NOI) for Storm Water Discharges Associated with Small Municipal Separate Storm Sewer Systems (SMS4)

To Be Covered Under The KPDES General Permit

### WHO MUST FILE A NOTICE OF INTENT (NOI) FORM

The operator of a small municipal separate storm sewer system(SMS4) in accordance with 40 CFR Parts 9, 122. 123, and 124 and 401 KAR 5:060, must submit a NOI to obtain coverage under the SMS4 KPDES Storm Water General Permit. #### COMPLETING THE FORM

#### SECTION I - Permittee Information

Give the legal name of the person, firm, public organization, or entity legally designated as the Permittee responsible for maintaining compliance with the approved Storm Water Phase II MS4 permit. Enter the complete address and phone number of the operator of the MS4 system(s) and co-permittees bound by the Storm Water Phase II MS4 permit as a part of this NOI. Include co-permittee list and legally binding MOU's in the Storm Water Management Plan (SWMP)

#### SECTION II - Storm Sewer Map

Include a detailed map of the storm sewer system indicating all storm water outfalls to the waters of the Commonwealth and delineating the separate watershed drainage areas.

## **SECTION III - Minimum Control Measures**

Include the current status of the listed control measures. If another entity is responsible for a particular control measure, indicate the entity as appropriate.

## **SECTION IV - CERTIFICATION**

Federal statutes provide for severe penalties for submitting false information on this application form. Federal regulations require this application to be signed as follows:

For a municipality, state, Federal, or other public facility: by either a principal executive officer or ranking elected official.
