Findings From Past Downhole Camera Inspections

The downhole camera has proven to be a valuable tool for water well and monitoring well inspections.

For the past couple of years, we have observed that open boreholes in eastern Kentucky, that are below the casing end, have a tendency to degrade when the static water level is in a fairly thick formation or thick shale formation. The degradation affects the well by filling the open borehole with the silts of the shale breakdown.

These wells have shown a substantial loss of reservoir capacity as well as shutting off A shale formation in the the water. reservoir of a well would be considered an undesirable geological formation and should be sealed off by installing casing or a liner.
