## Field Audits for 2004

There were seven water well driller field audits completed in 2004. The goal was to complete 10 audits, but with the unusual wet weather and a major office move by the Groundwater Branch, seven audits were considered a success. The audits provided a good opportunity for the water well drillers, driller program personnel and well owners to ask questions and exchange information related to well drilling and groundwater.

This year the Groundwater Branch will be continuing the audits and plans to complete at least 10 audits by the end of the year. As stated in earlier editions of this quarterly, these audits are conducted to improve communication between driller program personnel, water well drillers and well owners.

The water well drillers will be selected throughout the state and will be contacted by Joe Moffitt or Harold Lee to schedule a field review.

## NGWA Exam Reminder

---

As of January 1, the National Ground Water Association (NGWA) exam fees are now \$75.00 per exam. The NGWA has exam centers, through LaserGrade testing specialist, set up in several states in order for exams to be taken via computer. In Kentucky, the testing centers are located in Louisville and Mt. Sterling.

An applicant will go to one of these centers and take the NGWA exams. The scores will be seen immediately, and the applicant can provide the Groundwater Branch with the scores to be added to an application.

The Groundwater Branch will continue to provide the paper/pencil method until Jan. 1, 2007.
