

ADDITIONALLY, YOU MUST ALSO UNDERSTAND THE RELATED EXPENSES IN HARVESTING AND TRANSPORTING TIMBER FROM YOUR PROPERTY TO THE PURCHASING MILL. FARMERS AND LANDOWNERS WILL RECEIVE STUMPAGE PRICES LESS THAN THOSE LISTED IN THIS REPORT BY AS MUCH AS 50% OR MORE IN SOME INSTANCES. COSTS OF LOGGING VARY GREATLY DUE TO ACCESS, PROXIMITY OF THE TIMBER TO A MAIN ROAD, TERRAIN, DISTANCE TO THE PURCHASING MILL, PREVAILING CONDITIONS, SPECIES COMPOSITION, TIMBER QUALITY, TIMBER SIZE, FOOTAGE PER ACRE, MARKET SPECIES DEMAND, AND COSTS ASSOCIATED WITH THE USE OF APPROPRIATE BEST MANAGEMENT PRACTICES (BMPs).
