This spring the Department for Surface Mining Reclamation and Enforcement, Division of Field Services, closed its Regional Offices in Grayson and Jackson. The inspection responsibilities of these offices were transferred to the remaining Eastern Kentucky Regional Offices.

We have now established a-Satellite Office in Hazard, Kentucky to better serve you. The Hazard Satellite Office will be a drop-off point for bonds, permit applications, and other required forms. A Surface Mining Information System (SMIS) terminal has also been provided, but no technical assistance will be available at the Hazard Satellite Office. The satellite office will be open Monday through Friday, 8:00 a.m. to noon and 1:00 to 4:30 p.m.

Please review the addresses, phone and FAX numbers of all the offices carefully, because there have been several changes.
