Introductions

Tom Gabbard welcomed everyone to the new 300 Sower Blvd building and reminded everyone to sign in. Everyone introduced themselves.

Announcements

Samantha Kaiser was introduced as the new recorder, replacing Carole Catalfo. The Division of Water has had some employee changes, Joe Uliasz is the new Compliance and Technical Assistance Supervisory and Russel Neal is the new supervisor of Capacity Development. Bruce Scott is the new Deputy Secretary of EEC and Aaron Keatley is now the Commissioner of EEC. A short tour of building after the meeting was offered.

Jory Becker discussed the ongoing issue of wastewater treatment plant abandonment and will give a presentation at a future meeting to discuss how the Division is dealing with this issue. The Water Infrastructure Branch is in the process of making final documents available on the e-search portal. Any questions, comments, or concerns can be directed to Jory Becker.

The Division of Water is currently reviewing, consolidating, and removing regulations as part of the Red Tape Reduction Initiative.

Review Agenda

March 2016 Meeting Minutes

The March 2016 meeting minutes were approved by consensus.

### Review Sub-groups Assignments and Schedule

Sarah Gaddis discussed the Disinfection Byproducts (DBP) sub-group updates. DBPs violations have been increasing each year. The sub-group will be scheduling a meeting.

The Capacity Development sub-group did not have anything to report. The council wanted to discuss the history of capacity development. The council was formed because 20% of the State Revolving Fund (SRF) forms strategy needed to be revised. The council revised the three year strategy but the draft was never submitted to the EPA. There have been many discussions since then, but no implementation. This discussion was tabled until the next meeting.

### PFOA, PFOS, and Health Advisory

Rengao Song discussed the EPA's new health advisory perchlorate number as of May 2016, which are lower than previous numbers, PFO is 0.4 ppb and PFOA is 0.2 ppb. There have not been historical problems with Kentucky systems or with the river levels. Louisville Water has been monitoring the PFOs and PFOAs and will continue to monitor the levels.

There is currently little data on PFOS and PFOAS. Previously PFOS and PFOAS presented no issues, but items that need to be addressed are, how health advisories would be issued, how data will be collected, and which systems should be monitoring more often or whether all systems need to monitor.

### EPA's Inspector General Report – March 2016

Samantha Kaiser sent the EPA's IG investigation from earlier this spring to the members. The EPA identified issues with drinking water monitoring data and as a result the EPA is evaluating how SDWA primacy states monitor and report drinking water sampling results.

### RICE Rule and Registration for Generators

Jarrold Bell discussed the Reciprocating Internal Combustion Engines (RICE) Rule issued by the EPA. This rule applies to stationary engines only and establishes various requirements depending on the age, size, horsepower, etc. There are a few exemptions to this rule. Not many wastewater plants have registered their engines and generators, which can be registered with DAQ. The EPA has a flowchart that can be found at [www.epa.gov/region1/RICE](http://www.epa.gov/region1/RICE) to help distinguish if your device needs to be registered or a permitted. Emily Ohde explained that DCA has a program to help facilities register engines and apply for permits, if needed.
