## **Kentucky Division of Water**



The mission of the Kentucky Division of Water is to manage, protect and enhance the quality and quantity of the Commonwealth's water resources for present and future generations through voluntary, regulatory and educational programs.

### Intention

- To provide Cabinet/Department/Division updates and for industry, regulated community, engineering community, and consumers to provide input on drinking water and clean water issues
  - Drinking Water Advisory Council
  - Clean Water Advisory Council



# Per-and Polyfluoroalkyl Substances (PFAS)

- Drinking Water study
  - November 2019
  - 81 community public drinking water treatment plants
    - Surface and groundwater sources
    - PFAS detected at 41 of 81 WTPs
      - 31 of 43 surface water WTPs (72%)
      - 10 of 38 groundwater WTPs (26%)
- Study evaluating Kentucky Source Waters for PFAS Aug. 4, 2021
  - 40 surface water monitoring stations
  - PFAS detected in 36 of 40 stations
- Ongoing fish tissue sampling and analysis
  - Preliminary results and report expected soon
- Ongoing collaboration within DEP to begin sampling drinking water and wastewater effluent and biosolids
- UCMR 5
  - Sample collection for 29 PFAS and lithium between 2023 and 2025

#### Waters of the US (WOTUS)

- September 7, 2021 USEPA and USACE declare national vacatur and announce return to pre-2015 (Rapanos) regulatory regime
- December 7, 2021 Proposed rule defining WOTUS
  - <u>https://www.epa.gov/system/files/documents/2021-12/revised-definition-of-wotus\_nprm\_december2021.pdf</u>
  - Comments due February 7, 2022
  - DOW coordinating with other states, ACWA, ASWM on comments
- All 401 WQCs of Nationwide Permits (NWPs) current
  - February 25, 2022 40 NWPs and 1 new NWP go into effect
- Operating under DOW and US Army Corps of Engineers long-standing regulatory regime
  - Jurisdictional waters USACE broad-ranging authority




#### **Bipartisan Infrastructure Law (BIL)**

- Funds available via State Revolving Fund (SRF) Programs
  - Clean Water SRF
    - CWSRF Emerging Contaminants
  - Drinking Water
    - DWSRF Lead Service Line Replacement
    - DWSRF Emerging Contaminants
- Gulf hypoxia task force
  - Regional programs
- Federal guidance expected in Jan/Feb 2022
- Appropriations by September 2022 (anticipated)

### **DOW Priorities for 2022**

Accountability

- Provide strategic guidance on water infrastructure investments
- Continue department's PFAS-related work
- Continue Nutrient Reduction Strategy work and Gulf hypoxia task force participation
- Better use of IT investments (data collection, mapping) and website
- Continue Integrated Report and Triennial Review of WQS work
- Work toward institutionalizing environmental justice
- Enhance partnerships and collaborations where possible
- Engage DW/CW Advisory Council subcommittees and workgroups
  - Establish new subcommittees as necessary



### **Tasking the DW/CW Advisory Council**

- DOW will be asking committees, subcommittees, and workgroups for input
- Priority before March 2022 DW/CW Advisory Council meeting
- Allows for cabinet re-engagement of existing work groups
  - Capacity Development
  - Operator Recruitment and Development
- May require establishing new working groups
  - PFAS
  - UCMR 5
  - Triennial Review
